It has been another exciting year at Life Management Center as we continue to provide more services to our community. You are an integral part of our successes and we are proud to share those accomplishments with you. During our last year we added our FIT team to help families be successful after problems resulting from substance use disorders. We are also happy to report that The Life Management Foundation was successfully launched to provide support to our services for years to come.

In an effort to build strong families, the FIT team provides treatment to parents with behavioral health conditions and substance use disorders who come in contact with the child welfare system. FIT provides comprehensive services to these parents, including treatment for their behavioral health condition and substance use disorder, training on coping and parenting skills, and support in other areas that may be stressors for the family. All treatment is provided with the goal of healthy family reunification.

The Life Management Foundation was successfully launched with a wine tasting dinner held at Firefly in February that raised more than \$10,000 to support the services of Life Management Center. The foundation was established to provide funding and support for the long-term sustainability of Life Management Center services.

In addition to these accomplishments, we also:

- Served 13,135 children and adults,
- Delivered \$1,072,580 in charity care,
- Placed 145 children in adoptive homes,
- Provided help through 2,484 visits and calls to our Emergency Services,
- And much more.

This report is only a small glimpse into the services provided by Life Management Center. We hope this gives you an overview of the important work that is being performed within our community. As you browse through the report, we also hope that you will be proud of the work Life Management Center is able to accomplish through your help.

Providing for the WHOLE FAMILY



We all know that the health of family members can affect the wellbeing of the whole family. When a child has a mental illness, it is no different than any other illness and the family needs support to cope with the illness. This is something that Melanie knows too well. Melanie is a single mother who has two children (12 and 13 years old), one who has been diagnosed with multiple mental disorders and a learning disability.

Things have not been easy for Melanie and things just seemed to be stacking up against the family. Melanie has found it difficult to keep a job at times due to her own health issues. She has gone through six surgeries on her leg for vascular issues, which has kept her off her feet at times and when she was on her feet it was still hard to get around. There have been a few moves, including a move out of state, and at times the family has found themselves living with friends or homeless. At one time they were living in a home when a tree fell through the roof.

Melanie knew she and her children needed help, but it has not been easy. "I didn't even know what to do for myself," said Melanie. Christopher was referred to Life Management Center for his mental health disorders, but staff knew that Christopher could not be at appointments if the family didn't have food, housing and transportation. So, in addition to medical services, they began providing wrap around

services and helped Melanie in any way they could. After waiting for five years, Melanie was provided Section 8 housing and the staff helped them move, found donated furniture and other household items, helped them get utilities set up, and even helped with getting the kids transferred to their new schools. The move also placed the family close to a trolley stop so they were better able to access transportation. Even though her own health creates challenges, Melanie has been able to work part-time with light duty jobs. Today, Christopher is receiving the treatment he needs with the help of Life Management Center coordinating his appointments with his school. Things are beginning to stabilize for the family and they are meeting goals they set for themselves. Melanie is even thinking about going back to school.

Melanie explained how much wrap around services have meant to her. "It makes my heart a little lighter," said Melanie. "I have so much going on in my life. It's really hard. But if I have a bad day, I can just call and say I need to talk. I'm forever grateful for the help they have given me."

Wrap around services are provided for families where children have a diagnosable mental health condition to help stabilize the family. The services can include help with applying for and finding housing, finding transportation, locating food banks, finding school clothing, and more. Services can even include something as basic as providing families with information about free events they can enjoy as a family.

Creating FOREVER FAMILIES



“All they want is someone to love them and to feel safe.”

That is how one adoptive mother describes the desire of children in foster care or looking for an adoptive home. Marcia and her husband, Stephens, adopted five children in August 2016. The 4 boys and one girl came to their home as foster children after experiencing physical abuse in a home that had domestic violence and substance use problems.

Marcia and Stephens always knew they wanted to adopt. Stephens' father had been adopted and Marcia had wanted to adopt since she was 13 years old. They began fostering children a few years before they met their adopted children. One foster child was with them for a year, another for three months and even had one for just one weekend while the child was between placements. They were definitely moving toward adoption, but they didn't expect to adopt a group of siblings and become a family of seven. That changed after their two youngest children were placed in their home through foster care over two years ago. The children, ages 8 to 12, were separated into multiple foster homes and the couple saw the need for the children to be together.

Marcia says the biggest challenge was trying to understand where the children came from and to be able to facilitate the transition for them. Today they are doing great. According to Marcia the children are all happy and adjusting well, even receiving A's and B's at school. She says they have goals and aspirations that they are able to discuss and work toward as a family, which they do sitting at the table every day. Something that Marcia says is her favorite part of the day.

To those who might be thinking about becoming a foster or adoptive parent, Marcia says, "Take the chance. You have the chance to change the life of a child."

And to those who might have concerns about where the children have come from? "The kids aren't damaged, they just have experiences that they need help coping with," said Marcia.

Finding FOREVER FAMILIES

It can be difficult to find a home for sibling groups and the children pictured here are no different. They are in need of a forever family that will bring them back together. The children are very bonded and connected to each other, and they are looking for a fun and active family that will teach them and show them what having a family is truly like. The ideal family for them will provide a loving family environment while also setting and enforcing consistent rules and boundaries and providing them with the opportunity to strengthen their bond. The forever family for these children will also need to be open-minded and understanding that Melonecia is fiercely protective over her siblings and she will need one-on-one attention to teach her that she is allowed to be a child and that she and all of her siblings are safe. With a sibling group this large, it will be important that they are the only children in the home so each child can get as much individual attention as possible. The right family for these children will also have a great deal of experience with trauma informed care and be able to support the educational and emotional needs of the children.
